The event attracts 40,000 – 50,000 people.

Exhibitors must provide their own booth set up and displays. Displays must be professional and neat in appearance. Tent, table and/or chair rentals are available from:

Costs for rental for the event are: 10 x 10' canopy = \$150; 8' table = \$10; chair = \$1.50 each

Please let us know if you will be renting any of these items, so they can be placed on set-up day.

These must be ordered well in advance (by 3/29/2019)

Late orders will incur a \$150 delivery charge and additional late fee.

Load-in must take place on Friday beginning at 6:00 am, and load-out is Sunday at 4:00 pm. Load-in on Saturday morning is highly discouraged, and can take place only with express permission. Paid security will be present on both Friday and Saturday nights. Each display must be set up and ready for guests by 8:30 am both days. Displays must remain set up until 5:00 pm on Saturday and 4:00 pm on Sunday.

GENERATORS AND TENT STAKES ARE NOT PERMITTED. Electrical power is available on a VERY LIMITED basis; please contact Get Outdoors Nevada to see if this option is available at the time of your application. An additional charge of \$60 will be added to your application fee.

No mechanically reproduced sound or music can be played without previous consent.

Exhibitors are prohibited from distributing promotional materials containing, but not limited to, religious, fraternal, or political content. Literature on the organization's mission and vision is permitted.

The Spring Jamboree "Check-In/Information" booth will be clearly marked with flags and is located in Bicentennial Park if needed. It will be open at 6:00 am on Friday. You will not need to check-in prior to setting up as your space number and maps will be included in a packet mailed to the address provided in April. If you have any questions, Get Outdoors Nevada staff will be on site as well.

Exhibitors and Sponsors are responsible for the safety and liability of their own displays and product. You are responsible for the security of your space. Get Outdoors Nevada and Spring Jamboree cannot assume any responsibility for any loss or damage to any inventory or display materials for any cause whatsoever during the course of the event. Get Outdoors Nevada and Spring Jamboree cannot be held responsible for any fraudulent transactions accepted during the event. Security will be provided by volunteer workers and a paid security company on Friday and Saturday from 6:00 pm to 6:00 am.

Your assigned booth number must be displayed at all times and the emergency information on the back must be completed. Booth space must be clean before leaving the park at the end of the show or a fine of \$25 will be assessed and acceptance to any future events will be jeopardized.

Get Outdoors Nevada will be reviewing all registrations as they are submitted and will immediately notify the applicant if there are any questions or concerns. In extreme cases where an application denial is required, an immediate refund will be issued and returned to the applicant. If you have any questions regarding your registration, please contact our office at 702-997-3350 to resolve any concerns.

Exhibitor booth fees must be included with the application. The fees include a \$25 non-refundable application fee. Please use the online payment portal or make checks payable to Get Outdoors Nevada and mail them to 919 E. Bonneville Avenue, Las Vegas, NV 89130. If you cancel prior to April 1st, your fee minus the \$25 fee will be returned to you. Any cancelations after April 1st are not refundable and there are NO exceptions. All monies are committed at the time they are received to the promotion and presentation of this event. There will be NO refunds for inclement weather or for non-compliance of event rules and regulations.

Vendors: **Please clearly mark on the registration form if you would like to sell items at the event.** Upload your business license on the online registration form; if your organization does not have a license, there is a \$10 per day fee paid to the City of Boulder City for a Temporary Boulder City Business License, and sales tax must be paid at the close of the event. You are responsible for collecting sales tax during the event unless you are able to provide a current Nevada Department of Taxation Sales/Use Tax Exemption Number on the application.
